Subject: Request for Immediate Restriction of Operations in AITC Bank Accounts

Sir/Madam,

I, Aroop Biswas, acting in my capacity as the Treasurer of the All India Trinamool Congress (hereinafter referred to as "AITC"), write to bring to your attention a serious dispute presently prevailing concerning the authority and control of the affairs of AITC.

At present, rival groups are claiming to be the legitimate representatives and office bearers of AITC, resulting in uncertainty regarding the authority of persons who may seek to operate the bank accounts maintained in the name of AITC.

In order to safeguard the funds of the organization and prevent any unauthorized withdrawals, transfers, encumbrances or other transactions, I request your good office to maintain status quo and refrain from permitting any debit transactions or changes in operational mandates in respect of the following account maintained with your branch until the dispute is duly resolved or appropriate directions are issued by the competent authority:

In my capacity as Treasurer of AITC, I have previously faced considerable hardship and have been subjected to harassment by various authorities in relation to alleged discrepancies concerning the accounts and financial affairs of AITC. It is pertinent to mention that, in the ordinary course of functioning of the organization, I used to sign cheques for operational and administrative requirements, which were thereafter retained at the Party office for utilization in meeting urgent financial needs as and when they arose.

It is further a matter of public knowledge that a substantial number of elected representatives of the Party, including 20 out of 28 Members of Parliament and 58 out of 60 Members of the Legislative Assembly, have either left the Party or have openly revolted against the existing leadership. In these circumstances, a serious dispute has arisen regarding the authority, control and management of the affairs and assets of the Party.

In view thereof, there exists a genuine and reasonable apprehension that the funds belonging to the Party may be dealt with, utilized or appropriated by persons who are not duly authorized to do so. The funds of the Party ought to be preserved and utilized only by those persons who constitute the legitimate and authorized leadership and who are lawfully entitled to act in the name of the Party and exercise control over its name, symbol, assets and affairs. Immediate precautionary measures are therefore necessary to safeguard the funds of the Party and prevent any unauthorized or disputed transactions pending resolution of the aforesaid dispute.

Furthermore, in view of the present dispute regarding the authority and control of the organization, I have a strong and bona fide apprehension that the aforesaid signed cheques, if presently in circulation or custody of persons whose authority is under dispute, may be misused or presented for encashment without proper authorization. There therefore exists a real and imminent risk of unauthorized transactions being carried out through the aforesaid account.

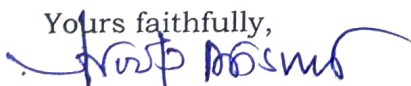
In these circumstances, any transaction undertaken during the pendency of the dispute may give rise to further complications and expose both the organization and me, as its Treasurer, to unwarranted liability and prejudice.

Urgent and immediate precautionary measures are therefore required, and I accordingly request that no transactions be permitted in the said account until the dispute is duly resolved by the competent authority. This request is made bona fide and solely with a view to safeguarding the funds of the organization and preventing any unauthorized or disputed operation of the account and further solely as a protective measure to preserve the funds of the organization and prevent any unauthorized or disputed operation of the account.

You are requested to acknowledge receipt of this letter and take necessary precautionary steps in the interest of safeguarding the account and the funds lying therein.
