PRESS RELEASE

Nair MARD Declares the Protest - No More Silence, No More Sacrifice

We, the resident doctors of Nair Hospital, under the collective leadership of MARD (BMC & Central) and supported by esteemed organizations including MAGMO, ASMI, IMA, MSRDA and others, are compelled to initiate a peaceful statewide agitation starting Monday, 3rd November 2025, in solemn solidarity with Dr. Sampada Mundhe, Medical Officer at SDH Phaltan, whose tragic death has laid bare the systemic failures in doctor safety, grievance redressal, and administrative accountability.

Nature of Protest-

- Outpatient Department (OPD) services will be suspended statewide
- Emergency, ICU, and lifesaving services will continue uninterrupted

Location & Time of protest-

- Near Gate number 1, in front of college building, Nair Hospital, Mumbai
- 10:00 AM-11:00 AM

Our Key Demands (To the State Government)

1. Formation of an Independent SIT under judicial supervision (Retd. High Court Judge + Woman IPS Officer)
2. Fast-track trial and prosecution in a special court under state supervision
3. Compensation of ₹5 crore and a government job for one eligible family member of Dr. Mundhe
4. State-level systemic reforms to ensure doctor safety and prevent recurrence of such tragedies

We **urge the administration, teaching faculty, hospital staff, and the general public** to stand with us in this fight for justice and reform. Your support is vital in ensuring that no doctor has to work in fear, and that tragedies like Dr. Mundhe's never happen again.
