office bearer/functionary of my client had approached some NC MLA's of Jammu region with offers of Rs 20-30 crores, a ministerial berth as bribe and restoration of statehood to switch side to BJP.

4. That you have further made allegations that a Senior BJP functionary/office bearer who is also a Lawyer practicing in Supreme court of India has offered bribe to NC MLA's.
5. That the said statement issued by you levelling allegations has been reported in print media, electronic media and on social media platforms.
6. That the allegations made by you are entirely untrue, malicious, and without any factual basis. The said statement issued by you, has seriously harmed my client's reputation, dignity, and standing in society and have caused immense damage to image of my client in public.
7. That the said allegations have been made without any basis, without any proof and the said allegations are absolutely false and have been made intentionally and willfully by you to harm the reputation of my client in the eyes of public.
8. That your statement and actions amount to defamation and are actionable under the provisions of civil as well as criminal law. Making false accusations with the intention of damaging my client/s reputation is unlawful and exposes you to legal consequences.

I, therefore, by virtue of this legal notice call upon you to

- o Withdraw the false allegations in writing.

- Issue an unconditional public apology within 7 days of receipt of this notice.
- Refrain from publishing or circulating any further defamatory material concerning my client.
- Immediately cease and desist from making or repeating any false or defamatory statements against my client.

In the event of your failure to comply with the above demands within the stipulated period, my client shall be constrained to initiate appropriate civil as well as criminal proceedings against you before the competent court, including proceedings for damages to the tune of Rs 100 Crores (Hundred crores) for defamation and filling of Criminal proceeding for defamation, and any other remedies available under law, entirely at your own risk and responsibility as to costs and consequences.

This notice is issued without prejudice to all other legal rights and remedies available to my client in law and equity.
