Subject- Kindly Restrain Bhanvi Singh and Pratyusha Shahi from coming to Silver oak Apartment and Rajbhavan Basti to harass us in our old age

Respected Sir,

- 1- I, Ravi Pratap Singh aged about 81 and Smt Manjul Singh, aged about 70 reside with our youngest daughter Sadhvi Singh who looks after us on a daily basis in Silver Oak Apartment, Opp CID Building, Gokhle Marg, Lucknow and Rajbhavan Basti
- 2- That we are extremely stressed by Bhanvi Singh harassing us for property and barging into the flat repeatedly to manhandle us and our daughter Sadhvi Singh and on several occasions has hit me, i.e. Manjul Singh, leaving me with blue marks.
- 3- That ~~yesterday~~ on 01-07-2025 Bhanvi Singh and Pratyusha Shahi came and they can be seen in the video recording that they are making aggressive gestures of hitting/slapping towards the door, in a way at us who reside in the flat to threaten us. We have heard that they have filed a case on us and Sadhvi Singh in Civil Court Basti last month and came here yesterday just to create a ruckus and get proximity to hit us and Sadhvi Singh.
- 4- That previously Bhanvi Singh had sent photo of a car to bribe our cook Vinod to harm us by mixing sedatives in our food and tell her about our whereabouts and we had to ask him to leave after seeing his Whatsapp chat history with her and photo of a car as bribe sent from her. ⁰²⁻⁰¹⁻²⁵ Yesterday she bribed our cook Sudha to say that Sadhvi Singh locked us up but as CCTV camera is installed inside the apartment it can be checked that our door was unlocked and we did not meet them at our own will. We even asked Sadhvi Singh to send the CCTV footage to the media who were calling her, hoping it would shame Bhanvi Singh from repeatedly creating a "tamasha" in our building as we are desperate of this harassment every 6 months to end.
- 5- That Bhanvi Singh and Pratyusha Shahi are creating a dangerous situation for us by bribing our house helps in our old age when we want to make it

very clear that when they have already filed a case on us in the Hon'ble Civil Court, Basti, for my/our property which they will never get, whatever needs to be spoken would be solely in court premises now. I, R.P Singh have in the presence of witnesses have given my power of attorney to Sadhvi Singh including the right to sell. Bhanvi Singh has misused my power of attorney in which I had not given her the right to sell but has duped me of money worth crores which is another matter.

- 6- That a few years back Bhanvi Singh and Pratyusha Shahi got the lock broken at my house in Rajbhavan Basti and attempted to burn down the mattress and physically mauled a doll by taking her eyes out and breaking her limbs in Basti despite my asking them not to enter my house. We are under great threat to our life and property from Bhanvi Singh and Pratyusha Shahi and urgently need Police protection from them.
- 7- That by this criminal conduct of repeatedly breaking in and using their connections and influence, they are a huge threat to our life and property by stalking us and bribing our house helps to seek information of our whereabouts, and are dangerous. They are well equipped to carry out a conspiracy of our murder and want to torture us by pulling us into a media trial based on false statement of the cook Sudha by bribing her as they earlier bribed Vinod, our previous cook, as they are greedy and shameless women and want to deny us our right to live with dignity.

PRAYER

- 1- That if Bhanvi Singh and Pratyusha Shahi come to Silver oak apartment, Lucknow or Rajbhavan Basti in my portion an FIR maybe registered against them for repeated harassment and manhandling and unlawful presence in our property and property of Sadhvi Singh as we fear for our life and property as Bhanvi Singh and Pratyusha Shahi are capable of our murder by bribing our househelps to stalk and possibly poison us as evident by the video of cook Sudha issuing false statemet
- 2- That Bhanvi Singh be issued a notice not to interact with my house helps and bribe them to lie to benefit them which can be easily negated by CCTV footage that throughout their public tamasha the door of my room was unlocked and we were moving around freely and were aware of their presence but chose not to meet them.

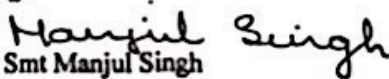
