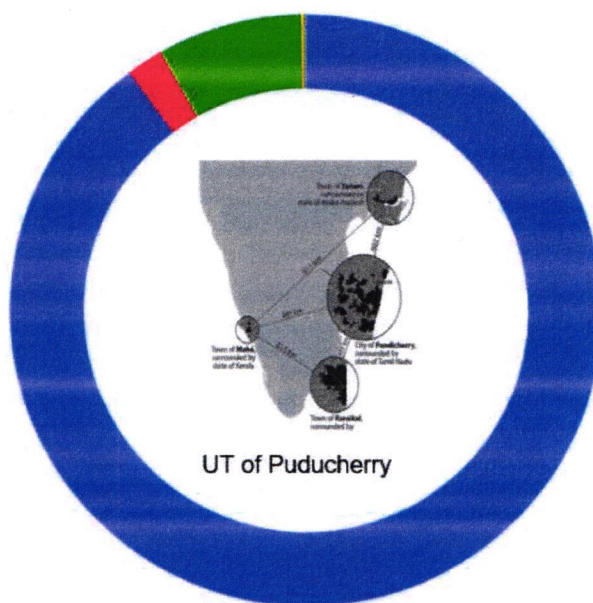

U.T. of Puducherry SIR: Enumeration Phase from 04.11.2025 to 11.12.2025



● EF collected from Electors(9.18 lakhs, 89.87%) ● Deceased(20798, 2.04%)

* BLO did not find these electors or did not get back their Enumeration Forms because they:

- Became electors in other States/UTs, or
- Were not found in existence, or
- Did not submit the form till 11th December, 2025 or
- Were not willing to register as an elector for some reason or other

Genuine electors can still be added back in electoral rolls during the Claims and Objection period from 16.12.2025 to 15.01.2026.

** The name of the Electors found enrolled at multiple places in Electoral Rolls will be retained only at one place.

The Election Commission of India (ECI) is implementing the Special Intensive Revision (SIR) of the Electoral Rolls in Puducherry with clearly defined objectives to ensure maximum participation of electors, complete inclusion of eligible electors, and full transparency at every stage of the process. The key objectives and activities undertaken under SIR are outlined below:

1. Participation of All Electors and All Political Parties

As on 16.12.2025, out of 10,21,578 electors, over 9,18,111 electors have submitted their Enumeration Forms, reflecting overwhelming participation in the first phase of SIR.

The successful completion of this phase is the result of coordinated efforts of DEOs of all 2 districts, 30 EROs, 30 AERs, and BLOs deployed at 962 polling booths, supported by volunteers. Field representatives of all 9 major political parties, including their District Presidents, also actively participated, with as many as 2,729 Booth Level Agents (BLAs) appointed by them. It is important to note that at the beginning of the SIR, the UT of Puducherry had only 888 BLAs. The increased number of BLA indicates active participation of the political parties and their representatives in this important exercise.

2. Ensuring No Eligible Elector is Left Behind

- a. To ensure universal awareness and participation, during the enumeration period, CEOs, DEOs and EROs conducted extensive awareness campaigns and held multiple meetings with political parties to explain the process and shared updates on the progress of the enumeration phase of SIR at regular intervals.
- b. Electoral Registration Officers held meetings with representatives of Recognised Political Parties before 05.12.2025 and handed over the tentative list of Uncollectable Forms so that it can be verified in the field by booth-level agents of Recognised Political Parties. Further, **the BLO-BLA coordination meetings were held by all 962 BLOs* with their respective BLAs to ensure thorough field verification of the ASD list.**
- c. BLOs also conducted meetings with booth-level agents to sensitise them as BLAs were permitted to file up to 50 Enumeration Forms per day to ensure their full involvement. BLOs visited homes of all electors listed on the rolls as of October 27, 2025, to hand out these forms and followed up with at least three collection visits. BLAs and volunteers worked diligently to include every eligible voter.

* Before rationalisation, Puducherry UT had a total of 962 BLOs. After the rationalisation on 11.12.2025, the number of Polling Stations has increased to 1,099.

3. Special Initiatives Taken

- a. Special Camps were held in all Polling Stations on 22nd, 23rd, 29th & 30th of November 2025 to facilitate coverage of all electors.
- b. As part of SIR, an exercise was conducted to optimise the number of electors in one Polling Station to a maximum of 1,200 electors. Accordingly, the Rationalisation of PS was carried out, resulting in an increase in the total number of Polling Stations in the UT to 1,099 Polling Stations from 962 Polling Stations, which is an increase of 137 Polling Stations. The DEOs have conducted meetings with political parties in this regard and briefed them on the increased number of polling stations.
- c. The increase in Polling Stations and reduction in maximum electors from 1,500 to 1,200 will increase voter convenience and will also facilitate better queue management on Poll day.

4. Inclusion of Young Electors

- Young electors who have attained or will attain 18 years of age on or before 01.01.2026 are being encouraged to apply through Form-6 along with the prescribed declaration.
- Special campaigns will be conducted across Puducherry on two weekends. Specific dates will be intimated soon.

5. Engagement with Electors and Political Parties

Booth-level lists of electors reported as deceased, permanently migrated or whose forms were not received were shared with the Booth Level Agents appointed by the political parties for verification.

6. Assistance by Election Staff and Volunteers

The entire election machinery, supported by volunteers, is assisting electors, particularly senior citizens, PwD electors and vulnerable groups. Special care has been taken by the DEOs, EROs & BLOs to ensure that such categories of electors are facilitated.

7. Redressal of Issues During Enumeration

DEOs of both the districts in Puducherry have personally addressed every issue reported through print, TV or social media to ensure that no grievance remains unattended.



8. Claims and Objections Phase: Scrutiny of Draft Electoral Roll

- As per the SIR Order, the Draft Electoral Roll has been published on 16th December 2025. Printed and digital booth-wise copies have been provided to all recognised political parties and made available on the CEO's website.
- Booth-wise lists of Absent/Shifted/Death/Duplicate electors whose names are not included in the Draft Roll, shall also be displayed on the Notice Board of respective Panchayat Bhavan/Urban local body office and Offices of the Block Development Officer/Panchayat Officers/Urban Local body officers to enable the general public to have access to the aforesaid voters lists along with the probable reasons for non-inclusion of their names and also these lists will be published on CEO's website (ceopuducherry.py.gov.in) in an accessible format.
- During the claims and objections period from 16/12/2025 to 15/01/2026, any elector or political party may file claims or objections for the inclusion of eligible electors or deletion of ineligible names. A total of 30 EROs and 30 AEROs are in position to scrutinize such cases. Additional AEROs are being appointed for this process for the elector's convenience.

9. No Deletion Without Due Process

- As per Para 5(b) of SIR guidelines, no name can be deleted from the draft roll published on 16th December without notice and a speaking order by the ERO/AERO. Any aggrieved elector may appeal to the District Magistrate and thereafter to the Chief Electoral Officer under Section 24 of the RP Act, 1950. Volunteers are also being trained to assist electors in filing appeals.
- The Commission reiterates its firm commitment to a transparent, participative and inclusive revision process, ensuring that no eligible elector is left out and no ineligible name remains in the Electoral Rolls.
- The schedule for claims and objections period and publication of final roll is as follows:
